OUR HISTORY

In 2022, we celebrated 30 years of delivering impact. We began as VicLink, a small team of commercialisation professionals focused on protecting University's intellectual property. Since then, we've grown to a 30 strong team spanning expertise in contract law, intellectual property, and commercialisation. In 2020, we became Wellington UniVentures. At this time, we were also gifted the Māori name Te Paewai, linking to the University's metaphor of the waka. Te paewai is a structurally vital piece of a waka that makes it suitable for long ocean voyages. This name speaks to our role as connectors who, by delivering impact through research, strengthen our University ecosystem, community, and society.

BIG WINS AT KIWINET AWARDS

The 10th annual KiwiNet Research
Commercialisation Awards were a big night,
with two of our four nominees winning in
their respective categories. Professor Justin
Hodgkiss won the Researcher Entrepreneur
Award, which recognises an experienced
entrepreneurial researcher who constantly
delivers real world impact. One of our earliest
spinouts, Magritek, won the Commercialisation
Impact Award. Judges called Magritek a
"trailblazer" whose pioneering impact on the
entire sector was hard to overstate.

THE LIFE OF LIQUIUM

Our new spinout Liquium successfully closed its \$1.5m seed venture investment round. Its promise to revolutionise the largest and most polluting chemical process on earth – ammonia production – has inspired many backers, including the Bill Gates' funded Breakthrough Energy Fellowship, which was awarded to Liquium co-founder Dr Franck Natali in 2021. Liquium's tech can make ammonia production more environmentally friendly and economically feasible – and potentially help develop an affordable, sustainable, hydrogen economy in Aotearoa New Zealand.



The spinout of our latest venture, the ultrafast spectroscopy developer Advemto, gives scientists greater insight into a world that's beyond the reach of even the strongest microscopes. Launched onto the academic market in March, Advemto attracted \$1.05m capital in its pre-seed investment round. It's already powering novel insights, including helping researchers better understand how skin cancer develops.


JANICE JOINS BIOVIROS BOARD
